UPCOMING CIVIC ASSOCIATION MEETING

Collaboration * Execution * Working for the Majority

Thank you for the survey responses we received in late 2016 regarding neighborhood cameras. We were hoping to gather two important pieces of insight from the surveys – an indication of where the neighborhood stood regarding the use of cameras and, were we to proceed, a wide-ranging list of factors that must be considered. Your input provided great direction on both fronts.

Since the survey was sent, our neighborhood (along with many others throughout Hillsborough County) has suffered various crimes. Numerous residents were victims of vehicle burglaries and thefts over the holidays. Another neighbor reported that glass panes were removed from their storage room along the side of their house in an apparent attempt to access the garage and home.

The survey results indicated strong support for cameras, and recent events have only seemed to reinforce their importance. During December, we held multiple team meetings among those who expressed on their surveys related expertise or interest in helping. We used these team meetings to discuss cameras, varying points of view gathered from the surveys (both the positives and the negatives), and the kind of comprehensive program that would be needed to effectively reduce crime. As a next step, we would like to vet our ideas and review next steps with the community atlarge



WHAT ARE THOSE PINK PLANTS?

Over the last two years, many volunteers have been hard at work



improving our entryways. To give some life and color to our beds, we added a variety of tropical plants in 2016. Plants were selected based on foliage, height, color, cold- and heat-tolerance, ability to handle varying water conditions, and ability to handle varying levels of sunlight.

Many of our shrubs have done very well and should adapt nicely to tiered hedges this coming season. Although we're happy with the overall look, there is clearly one star of the show -- our pink/red/purple (depending on the season) border plants. The most common question we received this year about our entryways focused on this plant, with many residents having asked, "What are those lovely pink plants?"

We used the Brazilian Red Hots variety of Joseph's Coat (also known as Alternanthera). The Joseph's Coat was rather a last-minute addition, pulled in for its contrasting color and eye-popping foliage. It grows as an annual in most climates, meaning it usually must be replanted each year. Because of our tropical climate, however, some plants can last for much longer. We are hoping this is the case for us. If not, they are easily and inexpensively replanted.

Where do you buy these lovely, colorful wonders? Different varieties of Joseph's Coat can be found during the growing season (spring-summer) in area nurseries. We found this variety through our local expert and wonderful partner, Bart Butler, owner of Southern Florida Landscaping. Bart supplied all of our plants and will be maintaining them for us in the coming years. He may be reached at 813-486-3727.

Keep watching for further growth, developments, and our seasonal plantings!

The yard decorating contest was won by the Williamses (Dana Shores & Venetian). Our runner-ups for the yard decorating contest are the Kings (Versailles).





We're fortunate to have the support of Hillsborough County Board of County Commissioners, which offers a grant funding the drop-off, use, and pick-up of the dumpsters. Here are some highlights of what you can expect.

LOGISTICS

WHO: Available to residents of Dana Shores, Pelican Island, and Sweetwater WHEN: Saturday, February 18,

from 8 a.m. - noon

WHERE: Skyway Park

Residents are responsible for getting items to the park and properly placing the items in the dumpsters. For those of you who own a truck, please consider how you might help your neighbor.

Residents who are unable to haul large items to the dumpsters may request help. Please email us at info@danashores.com before February 10 with your request. We have helped several individuals in prior years, and we will try to do the same this year.

WHAT YOU MAY DISPOSE OF

Several dumpsters will be available for our residents to dispose of large non-commercial items that would otherwise require a trip to the dump:

- Old refrigerators, ovens,
- · water heaters

- Steel and other metals
- Old furniture (e.g., couches, mattresses, chairs, tables)
- Tires
- Construction debris (e.g., concrete, bricks, glass, and roofing material)

ITEMS YOU NO LONGER NEED BUT DO NOT WANT TO THROW AWAY

The Dana Shores Women's Club (DSWC) is partnering with **THE SPRING OF TAMPA BAY** to provide a truck for donations at the event. They will accept clothing, working household goods, and gently used furniture). All items donated to **THE SPRING** help women and their children leaving the shelter rebuild their lives and also raise awareness to prevent domestic violence from occurring. <u>Tax</u> donation receipts will be available.

EXCLUDED ITEMS

We can take a variety of items, just not all items. The following <u>exclusions</u> apply:

- 1. Loose yard trash
- 2. Normal household trash
- 3. Waste from commercial activity
- 4. Electronic Items (such as computers/monitors, televisions, printers, cell phones, and batteries)
- 5. Hazardous items (such as paint, varnish, household chemicals, fireworks, propane tanks, prescription drugs, and fluorescent light bulbs)

<u>PUBLIC SERVICE ANNOUNCEMENT: Property Tax Relief May Be Available</u> Attorney Jeffrey P. Coleman, Fontainebleau Drive

If desired, significant tax relief may be available in the form of a tax deferral for some of our more "mature" residents. Real estate taxes ultimately need to be paid upon the sale of a property; however, there is a program available to help protect one's home and provide cash-flow relief in the meantime. Applications must comply with Florida statutes and administrative requirements of Hillsborough County, including the application deadline of March 1, 2017.

To defer real estate taxes and assessments, you must be entitled to claim the homestead tax exemption. Hillsborough County will charge a relatively small interest rate on the deferred amount, and that amount will constitute a lien on your real property.

The amount that can be deferred is based on age and adjusted gross income of all members of the household, and there are various circumstances and calculations that need to be considered. If, for instance, you are 65 years of age or older with an annual adjusted gross household income less than the household income limit for the additional homestead exemption under section 196.075 of Florida statutes (currently set at \$28,482), you may be able to defer the entire amount.
