






Dana Shores Woman's Club Annual Holiday Boutique




You're in good hands.

Westshore Pedestrain-Friendly Amenities



Then the trail was extended on the Clearwater side of the bridge, connecting the CCT and the Ream Wilson Clearwater Trail via the new Bayshore Trail. More recently another connection was made on the Tampa side -- between Cypress Point Park and West Shore Boulevard.

Ann Kulig, Executive Director of the Westshore Alliance, was recently quoted by 83 Degrees media saying that, "One of our top priorities is transforming West Shore Boulevard into a vibrant, pedestrian-friendly grand boulevard from Kennedy Boulevard north to Spruce Street." Dana Shores Neighborhood Watch Update




Holiday Awareness: Hillsborough County Sheriff's (HCSO) records show no reported thefts or burglaries in Dana Shores over last year's holiday season. This was great news and a marked improvement over the 2014/2015 season. Your eyes, ears, and work to keep the neighborhood secure make a big difference.

Still, we are not immune to issues. Over the past three months (7/16 -10/16), HCSO records show three calls from Dana Shores - an incident of vehicle burglary and one of vehicle theft that were reported through neighborhood watch along with a separate incident of grand theft.

In order to reduce the risk of criminals ruining this year's holidays, please remove all bags, boxes, and valuables from your vehicles before nightfall; lock all doors; and park vehicles in your driveway whenever possible. Going Batty?

Thirteen species of bats call Florida home, including some found species on Rocky Point Course Golf and in Dana Shores. Bats

offer several neighborly advantages, most notably their voracious appetite for insects and echolocation calls, which also repel insects.

Although bats prefer mayflies, wasps, and several other insects over mosquitoes, they generally dine on what is most readily available. When mosquito populations bloom after summer rains, many bats respond accordingly, consuming 1,200 to 2,000 mosquitoes per night.

Bat houses keep bats warm, dry, and safe, and they can attract bats to a specific area. For those who are interested, winter is a good time to install houses. This ensures their availability in the spring, when bats seek new roosts. Bat Conservation International (BCI) has researched the construction and location of bat houses over many years to determine the optimal criteria for attracting inhabitants:

- Our climate calls for house painted with a medium shade of flat, latex paint or a water-based stain. Internal temperatures should range between 80to 100-degrees F. (Adjust by reorientating the house (N/S/E/W), changing paint/stain color, adding side vents, or adding an overhang.)
- Multi-chambered. Each chamber +14 inches wide, + 2 feet tall, and no more than 3/4 inches deep.
- Open-bottomed. Interior partitions that offer rough surfaces between chambers (which bats will hang from), and are stained with two coats of dark, exterior -grade, water-based stain.

- A rough-surface landing area, typically extending 3- to 6-inches beneath the entrance. (Marked with horizontal grooves spaced 1/4 to 1/2 inch apart and no more than 1/16 inch deep.)
- Made from exterior plywood, cedar, plastic, or fiber-cement board; no pressure-treated wood.
- Watertight but not airtight. Careful caulking of all seams using latex caulk to prevent leaks. A 1/2-inch horizontal vent offering airflow along the entire front of the house 6 inches from the bottom.
- Mounted on a pole or building in a location receiving at least 6 hours of sunlight daily. (If using a wooden pole, include conical flashing to prevent predators from climbing the pole.)
- At least 20 to 25 feet from nearby trees, wires or other potential perches used by aerial predators.
- At least 12 feet off the ground. Ideally along the water's edge. Away from bright lights and human activity.
- In a permanent location where the sight, odor, and shoveling of some guano won't be a major issue.

Although a potentially long-term project (with bats taking weeks and possibly years to move into a house), this is also a great way to manage local insect populations while protecting our waterways.
