Dana Shores and surrounding neighborhoods did a good job of expressing the need for local repaving projects.

As of this writing, work is underway to repave Memorial Highway. If you ever wondered, your voice does make a difference!

I CAN SEE CLEARLY NOW THE SHRUBS ARE GONE

As outlined in our last newsletter, we reached out to Hillsborough County staff recently asking for their help in removing sight obstructions at the intersection of Dana Shores Drive and Memorial Highway. We did this after first hearing from Karin and Danny Miller (E. Eden Roc Circle) that residents were involved in catastrophic crashes at this intersection. Each incident involved a resident headed northbound when another motorist ran the red light in the eastbound direction along Memorial Highway.

We're fortunate to have a good working relationship with the County based on our efforts earlier this year to install decorative signs. This helped us know who to go to for help.

County staff were prompt in investigating our concern and the accident history at this corner. During their field investigations, they found the apartment complex's landscaping blocked the driver's view from Dana Shores Drive. As a result, they worked with the property managers, suggesting that they trim down or remove some of the landscaping so that drivers could see approaching vehicles on Memorial Highway.

The property manager agreed to remove hedges obstructing the view at this intersection and to re-landscape with shorter plants by the time this article is published. We hope this increased visibility allows our residents more reaction time and improves everyone's safety.

60 SECOND UPDATE

Earlier this summer, several residents noticed a set of pipes coming out of the ground near the middle of parcel 5 (the airport's property located directly south of Skyway Park and east of Doral Drive). Some have asked why the pipes were placed here and what they are used for.

In conjunction with requirements per the Florida Department of Environmental Protection, Tampa Airport has set up monitoring wells on surrounding parcels located north, east, and west of the airport. Water samples will be taken from these wells on a periodic basis over the next two years, while the airport's major construction projects are underway. This proactive monitoring of groundwater quality is another important step Tampa Airport is taking to ensure proper stewardship of their lands.

The first set of test results show pristine groundwater conditions in this location. Hats off to Tampa Airport!

CONTEST ANNOUNCEMENT:

HIGH SCHOOL STUDENTS, DO YOU TAKE GOOD VIDEOS?

Hillsborough County has experienced a steady rise in the number of resident and visitor pedestrians and bicyclists. Folks are walking and biking to and from work and school. Others are pursuing fitness and recreation.



Walking and biking are great ways to reduce pollution and stay healthy,

but unsafe use of the roads can have serious consequences. In 2013, over 1,000 pedestrian and bike crashes occurred in Hillsborough County, resulting in 43 deaths. Even one injury or fatality is too many, and we all share in the responsibility to make travel on our roadways safer for everyone.

Because peer-to-peer messaging is a highly successful way to reach teens, the Hillsborough MPO and its partners have invited local high school students to create short videos with walk- and bike-safety messages for their peers. The original videos must be created using a cell phone, mobile device, or video camera. Each video must be 30 seconds or less and focus on the basic rules of the road, such as crossing at crosswalks, avoiding earbuds and other distractions, and traveling in the proper direction.

Contest submissions are being accepted by the Hillsborough MPO through **February 1, 2016**. Eligible videos will be judged by a panel of experts, and the winning video will receive **four tickets to a** Tampa Bay Lightning game, compliments of the Columbia Restaurant Group. The winning video will be announced at a February 14 press conference. The video will be widely distributed as part of a multi-jurisdictional public safety campaign by the MPO and its partners, which include the School District, FDOT, City of Tampa, Hillsborough County, CUTR, and community safety advocates.

Students are encouraged to visit www.alerttodayflorida.com to brush up on traffic laws and safe behaviors for all road users. Free multi-media resources are available through Hillsborough County libraries (http://www.hcplc.org/hcplc/locations/hve) and County and City recreation centers to assist students with research and video production.
