

NOTICE OF PUBLIC HEARING  
ON ZONING DISTRICT CHANGES  
In compliance with provisions of Chapter 29131, Special Acts of 1953 of the Laws of Florida, a public hearing will be held by the Board of County Commissioners of Hillsborough County, at its office in the Courthouse in Tampa, Florida, beginning at 10:00 A.M. August 22, 1969 for the purpose of hearing studies and recommendations from the Hillsborough County Planning Commission on areas located in Hillsborough County and legally described as follows:  
Dana Shores Area being that portion of lands annexed from the City of Tampa to Hillsborough County and more particularly described as follows:  
Lots 1 to 24 inclusive, Block 1 and Lots 1 to 18 inclusive, Block 2 of Section "B" of Dana Shores Unit #1, Plat Book 33, Page 63; Lots 14 to 35 inclusive, Section "B" of Dana Shores Unit #2, Plat Book 34, Page 38; Lots 15 and 45 inclusive of Dana Shore Unit #3 Plat Book 36, Page 65; Lots 15 to 21 inclusive of Dana Shores Unit #4-A, Plat Book 40, Page 39; Lots 28 to 49 inclusive of Dana Shores, Unit #6-A, Plat Book 42, Page 19; Tract of land described as follows: From the center of Section 12, Township 28 South, Range 17 East, Hillsborough County, Florida, run south 01°07'00" west along the North-South center line of said Section 12, a distance of 1,309.37 feet to a Point of Beginning on the northerly limit of the City of Tampa as said northerly limit is set out in House Bill No. 734, Chapter 29348, Laws of Florida, Special Acts of 1953, from said Point of Beginning run South 43°42'42" east along said northerly limit of the City of Tampa 2877.29 feet; thence south 01°07'00" west 978.59 feet; hence north 89°36'06" west 386.0 feet; hence north 88°43'44" west, 371.44 feet; thence north 88°56'06" west, 350.67 feet; thence north 69°11'06" west 779.02 feet to the right of way line of Slate Road # 60; thence north 83°23'42" west along said right of way line 66.59 feet, thence north 89°11'08" west 935.59 feet along said right of way line to store-said north-south center line of said Section 12; thence north 01°07'00" east along said north-south center line 956.62 to the point of beginning.
