Undergrounding efforts are also moving more rapidly than TECO initially projected, and that's thanks to our residents. So many of you have been prompt in working on your individual connections, allowing TECO to maintain steady momentum week to week. This helps TECO keep many of the same contractors involved rather than having new crews come in periodically, and having that knowledge available promotes better support and service for the next homeowner. Our momentum has also allowed TECO to complete some of the restoration work more quickly than they expected.



I am extremely excited for residents of Versailles Drive. Versailles is the longest finger street and has 54 parcels. Yet, it is the closest to having all residents complete their portion of the undergrounding work. You are making great progress, and TECO is following up to make the connections as quickly as they can!

Please remember, once you complete the preparation activities outlined in the TECO letter, please contact TECO's undergrounding project manager, Mike Marston at 352.672.8622. Mike can also assist homeowners who have overhead service today and did not receive the letter from TECO outlining the preparation activities or the invoice for the connection between your home and the right of way.

TECO has committed to removing the legacy power system along the way. Once all residents of a finger street have been converted to the underground system, TECO can take the final and most anticipated step – removing the poles and overhead power lines for that street.

Our County Commissioners Who They Are and What They Do

Hillsborough county voters are represented by seven commissioners. Four of these seats focus on different districts (areas of the county). Three seats serve countywide. Collectively, this group makes up the Hillsborough County Board of County Commissioners (BOCC). If you've ever wondered how local government works, I recommend looking at the BOCC first.



This Board plays an important role in our lives.

The Hillsborough County Home Rule Charter, which was approved by local voters in 1983, assigns and vests numerous legislative responsibilities and powers of local self-government to the BOCC.

Our neighborhood is represented by the District 1 commissioner and the three countywide commissioners. Here, we would like to recognize our prior district commissioner, Commissioner Sandra L. Murman, for her work and provide you with an introduction to our new district commissioner, Commissioner Harry Cohen.



Sandra L. (Sandy) Murman served as our Hillsborough County Commissioner between 2010 and 2020, serving as Chairman of the Board of County Commissioners (BOCC) between 2014-2015 and 2017-2018.

Prior to joining the County Commission, she completed eight years as a member of the Florida House of Representatives and was the first female in her party to hold the position of Speaker Pro-Tempore.

As a longtime resident of Hillsborough County, Commissioner Murman focused on methods to improve communities. She has helped us with numerous efforts. In the last few years, she worked closely with our civic association and residents on undergrounding and proactively updating County planning language to restrict the fill-in of submerged lands.

Commissioner Murman also spearheaded many broader initiatives. Take a look at her website, and you'll see that she focused on the following: economic development and creating jobs through public policy; transportation; ending homelessness in the county; fighting the local opioid crisis; tackling human trafficking through awareness and education; addressing mental health issues through a successful Jail Diversion Program; and providing high-quality critical children's services in the county. In addition to her role with more than twenty-five other organizations, she founded the Women's Conference of Florida, the Women's Exchange, and the Blue Ribbon Committee for Child Safety; she spearheaded the campaign to build the Glazer Children's Museum; and she works with children in foster care through the Children's Home Network and serves as a Guardian ad Litem.

Many of us will miss our regular interactions with Commissioner Murman and her team. At the same time, we welcome District 1's newest commissioner, Commissioner Harry Cohen.

Harry Cohen previously served as a member of the Tampa City Council. Through this role, he was involved when we asked the City to stop the proposed fill-in project at Rocky Point and when we asked for help addressing zoning issues at the former Hogan's Beach. We will now be working with him in his new capacity with the County. Take a look at the County website, and you'll find the following about Commissioner Cohen.

A native of Tampa, Harry Cohen was elected to the Hillsborough County Board of County Commissioners, representing District 1, in November 2020. Harry Cohen has dedicated his life to a career in public service. A lawyer, Cohen served as the Chief Deputy Clerk of the Circuit Court of Hillsborough County from 2005-2011. He was elected to Tampa City Council in 2011 and re-elected in 2015.

Cohen has served the community in numerous capacities, including as chair pro tem of Tampa City Council, vice chair of the Metropolitan Planning Organization, and chair of the Transportation Disadvantage Coordinating Board. Cohen also has served on the Hillsborough County Public Safety Coordinating Council, Florida Orchestra, Ex-Officio Member, Board of Directors, Straz Center for the Performing Arts Board of Trustees and Executive Committee, and the boards of The Florida Aquarium and Community Tampa Bay.

The DEP's Environmental Stewardship Achievement Award Goes to Dana Shores Civic Association! Continued

Some of the Highlights -- Things You May Not Have Known (or Remembered)

Established in 1960, the Dana Shores Civic Association has a long history that aligns with the DEP's objective of protecting Florida. The association serves to foster, preserve, and improve quality of life; community pride; public lands and environmental quality; public safety; neighborhood infrastructure and appearances; community and social networks; and proper and lawful use of land, water and streets in and around the Dana Shores area as a voluntary civic group. (Yes, that's another mouthful!)

Throughout this group's history, many environmental opportunities have sprung up around water quality, habitat, and land use.

- Circa 1970, the Dana Shores Civic Association began working with the Hillsborough County Commission, then acting as the Air and Water Pollution Control Board, to alleviate pollution in our part of Old Tampa Bay stemming from private sewerage disposal plants and septic systems dumping effluent into Old Tampa Bay.
- Around 1980, association leaders worked with the County to get Dana Shores residences connected to a sewer system instead of septic tanks, which posed a perpetual problem for our estuary. Also in the early 1980s, the association fought hard to protect Rocky Point Golf Course from being developed, which continues to serve many species native to the Tampa Bay Estuary today.
- Fast-forward to the 2010s, the Dana Shores Civic Association has made many strides in protecting not only our waterways and lands but also those in the surrounding area. In 2013, leaders and residents worked to protect a tract of scenic land owned by the Hillsborough County Aviation Authority near Skyway Park from development into a Sportsplex.
- Starting in 2014, the DSCA began hosting annual cleanup events with residents trimming trees, removing 89,720 pounds of invasive species (Brazilian Pepper trees), exercising proper disposal of bulky items (such as tires), donating items to be reused

by local nonprofits such as The Spring and ReStore (Habitat for Humanity), and partnering with Hillsborough County Solid Waste to educate the public on proper disposal of hazardous and recyclable materials.

- In 2015, volunteers applied storm drain stickers/stencils throughout the neighborhood and initiated an ongoing educational campaign to remind residents to keep grass clippings out of the waterways, avoid overuse of fertilizers, clean up dog poop to avoid runoff into bacterial contamination of our waterways, eliminate mosquito breeding.
- In June 2018, the association worked with residents and other groups to fill the City of Tampa's Council Chambers to stop a dredge and fill project on Rocky Point Island. The group's leaders subsequently worked with County and City of Tampa leaders to add language to both entities' comprehensive plans to prevent this issue from arising again in the future.
- Dana Shores Civic Association leaders and neighborhood volunteers also began the annual Upper Tampa Bay Golf Tournament in 2018 to further support Rocky Point Golf Course and retain green space in the area.
- In 2019, the group worked with Hillsborough County to improve storm water drainage and install new no wake/slow speed zones in nearby areas.
- As part of the vision for 2020, the association is undergrounding our overhead utility lines, primarily to improve safety and reliability but also to foster our canopy of World War I memorial oaks along Dana Shores Drive. The group is also working on a bat habitat restoration and educational project at Rocky Point Golf Course via grant funding.
- As we look toward the future, the Dana Shores Civic Association is reaching out to consultants and agency partners and applying for grants to work on additional water quality and habitat improvements.

Sharing Christmas Joy



Nearly 3,200 children are in Hillsborough County's foster care system and, according to the most recent federal data, there are currently more than 400,000 children in foster care throughout the United States. Children and youth enter foster care because they have been abused, neglected, or either voluntarily or involuntarily abandoned by their parents or guardians.

In 2016, Dana Shores and Pelican Island residents provided Christmas gifts to 75 of these children, and each year since our residents have surpassed the prior year in the number of children we have touched.

Recently, the Dana Shores Civic Association (DSCA) partnered with the Guardian ad Litem and Voices for Children for our community's fifth year in a row. Despite the 2020 pandemic and cancellation of some of our annual philanthropic events, this year's neighborhood toy drive provided Christmas gifts to more than 125 local foster children.

We are grateful for the amazing kindness of the Dana Shores and Pelican Island residents. This year, our efforts also inspired the Springstead High School Jr. Air Force ROTC in Hernando County to get involved. This group of service-oriented teenagers raised more than \$800 for the project and did their own shopping for the requested items on the children's Christmas wish lists. The connection between the DSCA and ROTC was made through Cadet Major Chance Murphy, who is the grandson of Jeffy and Ralph Beaver. The Beavers have lived in Dana Shores for nearly 30 years.



