UNDERGROUNDING UPDATE – VERY EXCITING!!!

To date, the underground "backbone" has been put in place, overhead utilities along Rocky Point Golf Course's east and south perimeters have been removed, overhead utilities in front of The Cove at Rocky Point were buried, decorative lighting was added along Dana Shores Drive and finger streets, and the Verizon cellular tower across from Pelican Island was removed. Now we are approaching another major milestone- our first street to have the overhead system fully removed!



It looks like Versailles, our longest street with 53 residential parcels, will be our first finger street to fully remove the overhead system. The last check from Versailles residents to connect to the underground service was mailed to TECO as of the day of this writing, and we know many residents are eager to see the overhead lines and wooden poles on Versailles removed soon.

CONGRATULATIONS to all versailles residents and homeowners. Teamwork makes the dream work!

seems likely that West Eden Roc Circle or Fontainebleau residents will be next to see their overhead systems removed, although we know progress is also underway on Americana and East Eden Roc Circle.

Until this conversion is complete, all Dana Shores residents remain highly susceptible to storm-related power outages, particularly during hurricane season. The remaining overhead homes share the same circuitry with the underground homes, so a disruption to the overhead lines likely means a disruption to both overhead and underground facilities. We ask that if your home still has an overhead connection, please reach out to Mike Marston at 352.672.8622 to arrange next steps.

We also understand that TECO has just implemented a 20% price increase for various utility and underground-related work. For the short period while our undergrounding project remains formally open, we have been informed that TECO will honor the quotes mailed last year to our homeowners for conversion services.

Based on the number of households that worked with TECO to complete their conversion, it




UPDATE ON PICKLEBALL

As you saw in the May and July editions of the Shore Lines, residents reached out to the County Parks and Recreation Department earlier this year (and in prior years) to request that pickleball courts be added at Skyway Park. In follow up to this request, the County surveyed residents and learned that we generally have an equal community interest in tennis and pickleball but some pretty different opinions about adding pickleball lines to the existing tennis courts.

Based on these results, the civic association asked County representatives to evaluate the option of adding separate pickleball courts near the head of the bike path. We met with County Parks and Recreation representatives onsite in mid-July to discuss this idea and several other topics related to Skyway.

Hillsborough County representatives have committed to evaluating the feasibility of building separate pickleball courts in the aforementioned area. In the meantime, they plan to paint pickleball lines on one of the tennis courts to help gauge use and, if building the separate courts is feasible, develop their case for adding the additional courts.

The modified court can be used for both tennis and pickleball, and posted rules apply to both sports. The net will not change; it will remain at the height used for tennis. If separate pickleball courts are built in the future, the County has agreed to repaint the tennis court and remove the additional pickleball lines.

**UPDATE ON SKYWAY SPORTS
COMPLEX (locally known as
Skyway Park)**

As we shared in prior months, a number of concerns have been raised by



residents about the maintenance and operation of Skyway Park, particularly over the last six months or so. While some major investments have been made (e.g., new synthetic multisport field, new concrete patio around the complex pavilion, Bermuda grass on the ballfields, new scoreboards, new LED lighting around the facility, and new Florida-friendly landscaping), legitimate issues have also been raised, including concerns regarding the playground's condition, trash accumulation, and security.

In mid-July, leadership from the Dana Shores Civic Association met with representatives from County Parks and Recreation in hopes of developing a common understanding of the park's strengths as well as its opportunity areas.

By now, we hope residents have started to see some modest improvements. Additional trash cans have been added to the park; lids are on backorder. Tampa Police Department (TPD) has increased their visibility at the park. Vans that had started parking there 24 x 7 have not been spotted recently. Work has been done to clean up items that had been illegally dumped at the park, and measures have been put in place to dissuade future offenders. The enclosed area by the dumpsters has been cleaned out so that two of the dumpsters can be moved inside this area, reducing some of the blight of having four dumpsters onsite. Sidewalk repairs are underway in the playground area, and playground equipment that previously had rough, rusty edges has been sealed.

Although there is still much to be done, we are optimistic that improvements will continue.

The children's park has been moved to the County's top 10 list for equipment replacement. We have asked to be consulted as Skyway reaches the top of this list, and we have agreement from the County to engage the community in the design process. In addition, a number of other opportunities were discussed that we hope to share in the coming months.

In mid-July, a health advisory was issued for Ben T Davis Beach due to high bacteria levels. The following excerpts are taken from the Florida Department of Health notification.

Area water samples showed enterococci bacteria levels above the Environmental Protection Agency (EPA) standard. Until the advisory is lifted, **swimming is not recommended in the area**.

Although this notification was not for red tide, related caution signs were placed at Ben T. Davis and Cypress Point due to the presence of red tide and dead fish in much of the Tampa Bay area.



The Florida Department of Health in Hillsborough County has been conducting coastal beach water quality monitoring at nine sites once every two weeks since August 2000 and weekly since August 2002.

The water samples are analyzed for enteric bacteria (enterococci) that normally inhabit the intestinal tract of humans and animals, which may cause human disease, infections, or rashes. The presence of enteric bacteria is an indication of fecal pollution, which may come from storm water runoff, pets and wildlife, and human sewage.

EACH OF US MAKES A DIFFERENCE IN WATER QUALITY

As all members of our community know, water quality is an important topic to our residents. But it is one thing to know something is important and another to understand what each of us individually can do to make a meaningful difference in water quality. We hope you are enjoying this series of monthly articles and are learning something each month that can help. This month, our attention turns to the disposal of cooking oil.

Did you know that when you dispose of cooking oil in your kitchen sink, that this contributes to sewage spills and Bay contamination?



This is what a sewer pipe clogged with kitchen fats, oil, and grease looks like (see picture). When cooking oil is poured down the drain, it gels and solidifies inside of pipes, sewage lines, and sewage lift stations. This constricts water flow, causing back ups and equipment malfunction, which ultimately lead to sewage spills and overflows from Hillsborough County's wastewater collection system.

Just as many experts suggest that the Piney Point incident likely contributed to much of the red tide going on in Tampa Bay right now, sewage spills also contribute to red tide and high bacteria levels. In a very basic way, we can think of each one as a mini-Piney Point incident.

How can each of us make a difference?

1. Carefully pour cooled cooking oil and grease into a large, sturdy plastic or wax-coated container, such as the original container, a juice carton, or a Cooking Oil Recycling Effort jug.
2. Cap the container and store in a cool, safe location.
3. Keep the oil separate; do not mix it with any other liquids or products.
4. Once the container is full, bring it to a Cooking Oil Recycling Effort station or to a County Household Hazardous Waste Collection Center.

Nearby Drop-Off Stations: Bring your container of used cooking oil and grease to one of these locations at any time. Look for the brightly colored, free-standing cabinet with the Cooking Oil Recycling Effort (CORE) identification.


