LAST CALL: HOLIDAY PHILANTHROPY PROJECT WRAPPING UP!



Hillsborough County's Guardian ad Litem **Voices for Children** program advocates for over 3,200 children in the Hillsborough County foster care system. The DSCA has selected this program for this holiday season's philanthropy project, continuing the tradition started by the Dana Shores Women's Club in 2016. This provides an opportunity for residents and homeowners to get involved in providing Christmas gifts that are on the children's wish lists.


We need your help. As of this writing, we do not yet have sufficient participation to support the 50 children we committed to assist. Without help from us and others like us, nothing is placed under the tree for these children.

Guardian ad Litem suggests providing gifts with an approximate value of \$50 per child. Jeffy Beaver is collecting the gifts and coordinating delivery with the Guardian ad Litem office. The program also accepts monetary donations and gift cards, which volunteers use to purchase gifts.

Because of some security issues that arose during the 2020 gift campaign, we request that none of the items be giftwrapped. We will accept donations of wrapping paper, ribbon, bows, and tags so the items can be wrapped after they have gone through inspection.

NEXT STEPS FOR UNDERGROUNDING

Versailles has completed their undergrounding work, and many are asking about the status of the remaining streets. As of this writing, five homes were released last week for conversion, meaning these homeowners had completed all prep work and paid their TECO invoices.

We have five remaining streets where homeowners still need to pay their invoices, complete their prep work, or both.

1. Homeowners on East Eden Roc Circle have made the most progress recently
2. 3 streets have only 1 homeowner whose work is outstanding or in progress
3. 1 street has only 2 homeowners whose work is outstanding or in progress

It's time to wrap this project up!

For anyone with overhead electrical lines still attached to your roof, if you have completed your prep work and are ready for inspection, believe you have paid the invoice but TECO has not yet connected you to underground service, or if you do not recall receiving the TECO invoice, please contact Mike Marston at 352.672.8622 for assistance. He can confirm whether you are on the schedule, put you in touch with the right folks to help track down any payments that have not been applied, or take your email address and have a copy of the invoice sent to you.

If you need help or have questions about the project, you are welcomed to email the DSCA at info@danashores.com. We will work with you to answer the questions we can or get you to the folks who can.

1. Prep and Call for Inspection

In 2020 TECO mailed letters to each homeowner who had overhead service. The letter listed prep work that would be needed for the home.

Once prep was completed, homeowners were asked to contact the TECO project manager at 352.672.8622 for inspection.

2. Pay TECO Invoice

In 2020 TECO mailed invoices to each homeowner who had overhead service.

The invoice covers the cost of connecting to underground (U/G) service.

3. Connect to U/G Service

Once steps 1 and 2 are complete, Barrow Electric will install and connect a service line running between the transformer (green box) in the public right of way and the meter box on your home.

UPDATES FROM TAMPA AIRPORT



Last month we announced that Tampa Airport recently began a study to evaluate the potential costs, benefits, and feasibility of constructing an acoustic noise barrier to reduce airport noise affecting Dana Shores residents. Work should be completed around the end of the first quarter 2022. We look forward to learning more at that time. In the meantime, we have a few additional updates.

We've been informed that there will be prolonged closures of Tampa Airport's two primary runways beginning early next year.

- The Airport's east runway, Runway 1R-19L, is expected to close continuously beginning January 5, 2022, through February 18, 2022. During this time, most aircraft will use the Airport's west runway, which will likely increase aircraft noise levels for Dana Shores residents.
- The Airport's west runway, Runway 1L-19R, is expected to close continuously beginning April 20, 2022, through June 3, 2022. During this time, most aircraft will use the Airport's east runway, which will likely decrease aircraft noise levels for Dana Shores residents.

Both closures are necessary to accommodate FAA-required grading and drainage improvements and other runway maintenance projects.

On a final note, Tampa Airport recently announced the launch of their 2022 Master Plan Update (MPU) to support the next 20 years of growth at the airport. The work in 2012 led to the major changes you're seeing implemented today at Tampa Airport. The upcoming MPU will initially focus on demand forecasting and use of Airside B. Community engagement is currently scheduled for the second quarter of 2022. Opportunities and workshops will be posted on Tampa Airport's website.



NOT OUR TRASHCAN

Please be aware that dumpsters at Skyway Park are not available for residents' use. Hillsborough



County's Parks and Recreation security team is now involved due to recurring issues at this location, and they have found Dana Shores residents placing items in and around the dumpsters.

Dumping is unsightly and hazardous, and it encourages more dumping. As of this writing, we just saw large plates of glass were recently placed near the dumpsters, which create a safety hazard for children and others who use the park. Please help stop this activity. The park should not be our trashcan.

PUBLIC-SCHOOL OPTIONS FOR DANA SHORES FAMILIES

Potential buyers, new homeowners, and current homeowners have asked many questions over the years about public-school options for their children. In anticipation of upcoming application deadlines and school expos, the Dana Shores Civic Association has summarized some important information about the local school options.

We are zoned for Dickenson Elementary, Webb Middle School, and Jefferson High School. (Learn about school grades at <https://edudata.fldoe.org/ReportCards/Mapping.html>)

In addition to these and various private-school options, several other programs are available to our residents within the Hillsborough County Public Schools system. These include magnet programs, school choice, choice attractor programs, and charter schools. These programs are helping shape the minds of many of our nation's best and brightest, and several options exist within a 6-mile radius.

The brief application period for the August 2022 start date ends **December 11**. Family notifications are scheduled for late January 2022.



And don't forget your newspaper! (<https://myaccount.tampabay.com/Vacation>) Alternatively, consider asking a neighbor to pick up packages while you are away.

Having Visitors?

The Florida Offender Alert System is a free service provided through a partnership between the Florida Department of Law Enforcement, the Florida Sheriffs Association, and the Florida Police Chiefs Association. You may use this website to subscribe for an e-mail alert in the event a sexual offender or predator moves close to any address in Florida you choose to monitor, such as your home, workplace, school, or daycare. 

THE ABCDEs OF MELANOMA


The weather is one of the top reasons many of us live in Florida, and outdoor activities such as boating are a major draw to our community. But **too much exposure to the sun's ultraviolet (UV) rays** can cause skin cancer, the most common type of cancer. The American Cancer Society estimates that more than 5 million skin cancers are diagnosed each year in the United States.

Melanoma is the deadliest form of skin cancer. However, when detected early, melanoma is highly treatable. You can identify the warning signs of melanoma by looking for the following:




A for ASYMMETRY

One half of the spot is unlike the other half.




B for BORDER

The spot has an irregular, scalloped, or poorly defined border.




C for COLOR

The spot has varying colors from one area to the next, such as shades of tan, brown or black, or areas of white, red, or blue.



D for DIAMETER

While melanomas are usually greater than 6 mm, or about the size of a pencil eraser, when diagnosed, they can be smaller.



E for EVOLVING

The spot looks different from the rest or is changing in size, shape, or color.






