SKYWAY PARK UPDATES

FOOTBALL FIELD

In September, TBYFL came under new leadership, and in early December several residents raised concerns regarding trash pickup; activities of unattended minors; and misuse of space for warmups.

DSCA volunteers, County Parks and Rec representatives, and the new President of TBYFL sat down a few days later. DSCA representatives brought forward the issues shared by our residents and all meeting attendees worked together to identify opportunities for improvement, including several pilots that were to be introduced the upcoming weekend.

While there were a few things that were addressed from the list, TBYFL's new leaders unfortunately did not fulfill most of the agreed upon next steps. County representatives were onsite and have firsthand knowledge of the issues.

At the time of this writing, TBYFL's Superbowl remains suspended until further notice and several other group events have been canceled. DSCA representatives have remained in close contact with numerous representatives in local government, provided photographic and video evidence to support related investigations, and continue to monitor next steps. At this point, it appears the County is taking strong action to ensure the safety of all. We will let you know as we learn more.

CHILDREN'S PLAYGROUND

In August, Toni Jabaay, Katie Heckert, Colleen Adams, and Holly Simmons volunteered to work with the DSCA on a variety of improvements to the children's playground at Skyway. While many small, important improvements have been made, upgrading the broken chain link fencing to aluminum fencing in late December marked one of the first major milestones. We look forward to 2022 and other major improvements, including shade, a water fountain, and new playground equipment. In the meantime, many thanks go to this team, our County partners, and roughly 50 residents who donated money for playground improvements.

Updated statistics show that nearly 3,500 children are in Hillsborough County's foster care system (up 300 from 2020 statistics) and, according to the most recent federal data, there are currently more than 400,000 children in foster care throughout the United States. Children and youth enter foster care because they have been abused, neglected, or either voluntarily or involuntarily abandoned by their parents or guardians.

For the sixth year in a row, Dana Shores and Pelican Island residents provided Christmas gifts to these children. We have again received feedback that we are the top community donor, providing gifts to roughly 100 children this year.

Last year, our efforts also inspired the Springstead High School Jr. Air Force ROTC in Hernando County. This group of service-oriented teenagers recently doubled what they did last year, raising more than \$1,800 for children's gifts. The connection between the DSCA and ROTC was made through Cadet Major Chance Murphy, who is the grandson of Jeffy and Ralph Beaver. The Beavers have lived in Dana Shores for roughly 30 years. In addition, our efforts we have piqued the interest of another nearby waterfront community. We hope to announce their community partnership next year.

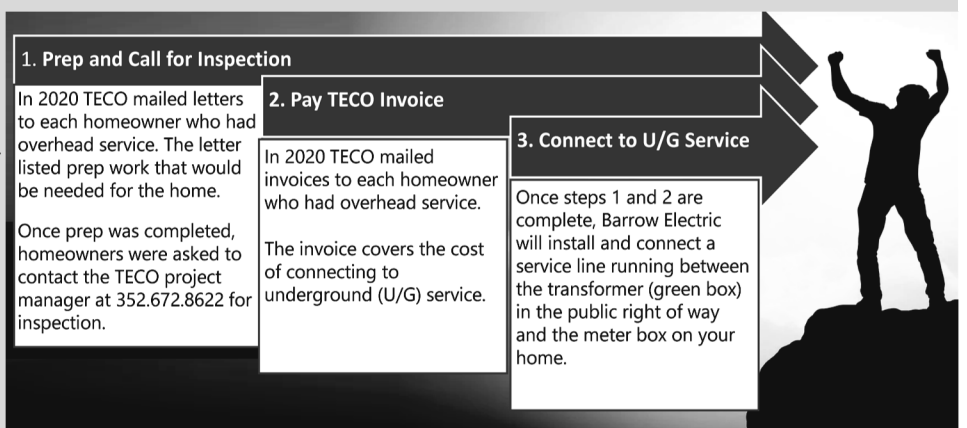
NEXT STEPS FOR UNDERGROUNDING

We have five remaining streets to underground: East Eden Roc Circle, West Eden Roc Circle, Fontainebleau Drive, Americana Drive, and (once the finger streets are completed) Dana Shores Drive. It's our understanding from homeowners and TECO that homeowner activity is underway for roughly half of the remaining homes with overhead service.

We are looking forward to getting this project wrapped up! Recently, one of the few remaining power lines fell across Eden Roc Circle, creating a hazard for residents. It's a good reminder of why we should have this project wrapped up soon. We are also excited to start work on several neighborhood beautification projects as soon as undergrounding is completed.

For anyone with overhead electrical lines still attached to your roof, if you have completed your prep work and are ready for inspection, believe you have paid the invoice but TECO has not yet connected you to underground service, or if you do not recall receiving the TECO invoice, please contact Mike Marston at 352.672.8622 for assistance. He can confirm whether you are on the schedule, put you in touch with the right folks to help track down any payments that have not been applied, or take your email address and have a copy of the invoice sent to you.
