Good news! Work to close the sidewalk gap that previously existed on the north side of the causeway between Bayport Drive and the Westin has completed several months early. This is a great complement to the surrounding trails and allows trail users access from Dana Shores to the Westin, Bahama Breeze, and other resources without crossing the Courtney Campbell Causeway.

This project is the direct result of the Dana Shores Civic Association's (DSCA) involvement on the Courtney Campbell Scenic Highway Corridor Advisor Committee (CCSHCAC). Jeff Coleman (former Fontainebleau Drive resident) sat on this committee on behalf of the DSCA. He knew from his own experience that not only would residents benefit from having this gap in the trail closed, but so would numerous commuters who use the trail to reach work each day on north Rocky Point Island. Jeff worked through the committee and FDOT to see this vision come to reality.

We greatly appreciate Jeff's work and the work that other members of the DSCA do on our community's behalf through their participation in various outside boards and committees. Jeff has been succeeded on the CCSHCAC by both Allison and Brian Roberts, residents of Americana Drive.



ASSISTANCE ADDRESSING A SAFETY ISSUE



We need help addressing a safety issue. Several homeless have moved in along the U-Path (the path that connects Skyway Sports Complex and the Courtney Campbell Trail). They are living in the area and have been seen doing drugs, defecating, etc.

This is a relatively isolated and dark commuter path. Recent

pedestrian counts show roughly 200 people use the path every day -- many are going to and from work on Rocky Point Island since this is the largest employment hub within the City limits without access to public transportation. That means many men and women are using the path by themselves in the wee morning and late evening hours.

This was discussed with a Tampa Police Department (TPD) Captain who asked that **EVERY TIME** anyone sees a vagrant or homeless person living here, that a report be submitted to TPD with details. Many of our residents routinely use the path, and we are requesting your help with this effort.


- Download the Tampa PD Google or Apple App at <https://www.tampa.gov/411>
- Call TPD non-emergency at 813-231-6130

Please store these options on your phone so they are ready when you need them. Although it is not monitored 24x7, the app is nice because it also has a location finder and it is easy to upload pictures. Alternatively, you can describe the location to an

operator - e.g., on the U-path roughly halfway between Skyway Sports Complex and the Courtney Campbell Trail OR near the Frontier Comm Station located on Bayport Drive where it intersects with the U-path.

Please remain safe. If you feel you are in immediate danger, dial 911

Thank you for your help! It is our hope that we can promote safety for commuters and those using the path for recreation while, at the same time, assist the homeless in obtaining services that improve their living conditions.
