Beginning on Thursday, January 11, Dana Shores resident, **Diane Mayes** (Americana Drive) will volunteer with Hillsborough County Parks & Recreation as an instructor for beginners. She is available by appointment at JSCC between 9:30 a.m. - noon on Thursdays (and sometimes Sundays). Lessons are free of charge.

Residents 18 years and older wishing to play on the indoor courts will need to purchase a Wellness Access Pass, which is \$10 per person plus tax per calendar month. Register online at <https://www.hillsboroughcounty.org/locations/jackson-springs-community-center>. This pass also entitles you to play indoors at the Westchase (10-noon Mon, Weds, Fri and 1-4 p.m. Sun) and Northdale courts (9:30 – 12:30 p.m. Tues & Thurs and 9:30 – noon Sat). Normal hours may change during holidays and summer children's camps. Outdoor play at Skyway remains available and does not require a pass.

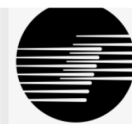

Gifts of Hope & Joy

Together, we continue to build upon the partnership established between the Dana Shores Civic Association, Hillsborough County Guardian ad Litem (GAL), and Voices for Children (VFC) nine years ago. Our work with GAL and VFC started in 2015 when former neighborhood association president, Julie Bowers, received a last-minute emergency phone call from one of their representatives asking if Dana Shores might be able to assist them during the holidays. Our neighborhood had a long history of philanthropy, and residents sponsored 28 children that year. Since then, we have given gifts to an estimated 850 children in total, an average of nearly 100 children per year.

GAL represents more than 4,000 local children who have been neglected, abused, or abandoned, providing simple necessities such as clothing, new shoes, and school supplies throughout the year. **We were GAL's top community holiday donor again last year, working with GAL to ensure that at least 160 local children had something under the tree for the holidays.**



Our success is largely a credit to the great work and volunteer efforts of **Jeffy Beaver** (E. Eden Roc Cir.). Jeffy is the heart and soul of this initiative. This year, she coordinated donations for 100 children's wish lists and then held the Holiday Boutique at her home, allowing us to sponsor another 60 children. Amazing!

Jeffy's work was complemented by a great team, including her husband **Ralph Beaver**, **VeeAnn Mahdieh** (E. Eden Roc Cir. resident and owner of Sugar Bar) who prepared our dinner for the boutique; **Linda Mills** (Versailles Dr.) and **Carla Markowitz** (former Doral Dr. resident and forever friend) whose combined auctioneering skills and humor were impressive; and **Tina Mawn** (Versailles Dr.), **Tiki Kirk** (Versailles Dr.) and **Holly Simmons** (Dana Shores Dr.) who kept everything organized and going at the boutique!
