

### MENTORING MAKES A DIFFERENCE!



Each year, our residents make a significant difference in the lives of local children in foster care. Through our collective efforts, we let them know that someone is thinking of

them and there is reason for hope and joy over the holidays. For those interested in doing more, we now have another avenue open to us throughout the year by becoming a mentor.

Mentorship can make a lasting impact and change the trajectory of a foster child's life. You can now be partnered with youth through the Florida Guardian ad Litem Office and serve as a committed, caring adult for foster youth transitioning to adulthood, providing a lifeline for questions and advice related to living independently. Here is how you can get started:

- Attend an online orientation and training session.
- Submit an application and sign a confidentiality form.
- Once your application is approved, complete an interview and Level II background check. (Attorneys in good standing with The Florida Bar are statutorily exempt from the background check process.)

## INAUGURAL FAMILY FUN DAY AT SKYWAY



## POSITIVE CHANGES ALONG THE CAUSEWAY

In addition to the list of ongoing efforts within the neighborhood, the Dana Shores Civic Association, our residents, and volunteers also work on and in select areas surrounding Dana Shores. One of these areas is the Courtney Campbell Scenic Highway and trail. It fits with several aspects of the DSCA vision and strategic imperatives:

- Promote and protect public safety, property values, and quality of life in Rocky Point
- Improve public lands and waterways that surround Dana Shores
- Foster appropriate planning to link the Courtney Campbell Scenic Highway Trail with future trails
- Forge strong relationships with surrounding communities, businesses, and government

The Courtney Campbell Causeway serves as a regional transportation corridor, a critical evacuation route for Clearwater residents, a recreational jewel, and the only scenic highway in this part of Florida. In many ways it is a treasure. It is also susceptible to storm damage and can be difficult-to-manage in other ways.

FDOT now has a comprehensive effort underway to address erosion issues and resiliency needs along the causeway. Work is in progress to perform non-structural repairs associated with recent storm damage. Completion of this work is estimated in April or May. In addition, work was recently awarded to address scouring along the pilings of the main bridge span, and a longer-term resiliency study is underway to determine appropriate measures that can help the causeway and trail withstand future storm damage.

Many thanks to **Allison and Brian Roberts** (Americana Drive), **LeAnn and Danny Anseeuw** (Fontainebleau Drive), and **Renee and Bob Saltzman** (Versailles Drive) for their efforts in pushing critical initiatives forward in this area. The Anseeuw and Saltzman families have provided great insight into a variety of issues and needs in this area, including pictures related to progressive erosion over the past few years. The Roberts family serves on the Courtney Campbell Scenic Highway Corridor Advisory Committee.
