## REMINDER: PLEASE CLEAR THE WAY FOR UPCOMING ROADWORK

♥ ♥ ♥ REPRINT FROM MAY 2025 (with minor edits)

Hillsborough County plans to begin resurfacing work on Dana Shores Drive (Memorial Highway to George Road) and along neighborhood finger streets (south of Dana Shores Drive) the first week of June 2025!

The work is scheduled to occur on weekdays from 8 a.m. to 5 p.m. weather permitting. To help ensure a smooth process, please remove all vehicles from the roadway during business hours and refrain from using your sprinkler systems while construction is underway.

We know this request is difficult given the number of contractors we have in the neighborhood at this time, but it is imperative to allowing this important work to proceed. Perhaps each of us working together can provide access to unused driveways where needed. We're not sure how it would work for any homeowners who have vehicles parked in front of their home, but we are sure no one wants their area to be skipped!

We understand that variable message boards will be placed along Dana Shores Drive to remind us of the work and door hangers will be distributed to residents in Dana Shores prior to construction. Before resurfacing begins, the contractor will also perform concrete work to repair significantly displaced gutters and sidewalk ramps.



## WATER, WIND, and FIRE



Dana Shores has faced several perils over the last year. It has been highly unusual, difficult in many cases, and even scary. We hope we have decades before we face similar challenges. But before we fully turn the page, let's make sure we reflect on the help we have received from others – including those who responded on April 24 to the brush fire on the open parcel immediately south of Skyway Park.

When help arrived that day, the fire had consumed roughly three acres. Dry conditions facilitated its spreading to roughly ten acres before it was ultimately extinguished. But thanks to Tampa Fire Rescue's and Tampa Police Department's swift, coordinated response from land, air, and sea, we have not heard of any reports of injury or property loss.

municipalities also provided critical support. Tampa Airport coordinated with firefighters and the FAA to ensure safety of flight operations. Hillsborough County enacted a County-wide emergency ban on open burning the following day to protect other neighborhoods. (As of this writing, the ban has since been lifted based on recent rain events.) The Florida Department of Forestry brought in a large crane several days later to remove badly burned trees.

Many homeowners have asked what caused the fire. DSCA Leaders have been informed that the cause could not be determined, and we have no other insight into the cause. That being said, if you see something nefarious or out of place on this property, we want to ensure you know who to call – just in case...

If you see an issue that requires immediate attention, call the 24-Hour Airport Operations Center at 813-870-8770. We suggest programming this number into your cell phone. If you call, be prepared to provide your contact information and the location of the reported event (Tampa Airport property south of Skyway Park, aka Parcel 5).


