For the 11th year in a row, the Dana Shores Civic Association will again partner with Santa Claus and the Hillsborough County Guardian ad Litem (GAL) and Voices for Children for our annual philanthropy project. GAL represents more than 4,000 local children each year who have been neglected, abused, or abandoned and, during the holidays, GAL works to ensure each child has something under the tree. Thanks to the efforts of our neighborhoods – Dana Shores, Pelican Island, and The Cove – we have been GAL's top community donor for several years. Your generous donations fulfilled the wishes of almost 150 children last year.

We will post a Wish List that can be viewed at <https://danashores.com/GAL> by October 25. This list contains the age and gender of each child and an item they'd like to have. Items range from toys to art supplies, from electronics to clothing, and from sports memorabilia to books. The average value of each gift is around \$50. In prior years, many items have been purchased online. We also have a bunch of anxious elves that love to go pick out presents, and we accept gift cards, cash donations and checks. 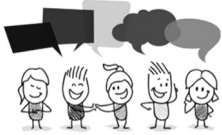

PROTECTING OUR NEWLY RESURFACED ROADWAYS



The roadway resurfacing project proceeded for a variety of good reasons even though we knew there would be risk of accelerated wear and tear on our roadways over the next several years as post-hurricane residential reconstruction continues. This short article is intended to help highlight a useful tip that we can all learn from.

Take a look at the circled areas in this picture, which show how one Dana Shores homeowner had contractors place plywood under both ends of the dumpster during construction. Inserting $\frac{3}{4}$ " plywood under each end of the dumpster spreads the weight, protects surface integrity, and reduces heat damage. It is a common practice that individual homeowners can require of their contractors and subcontractors, as some drivers will skip this step otherwise.

Please be aware that even if dumpsters are placed in your driveway, contractors will often need to drag them into the street or temporarily place them there while switching out dumpsters. The risk of damage is highest when the dumpster is being moved.

If we all take precautions to protect our roadways, we can make a significant difference in moving Dana Shores forward while protecting our wins along the way.

FLORIDA SEXUAL OFFENDERS & PREDATORS

OFFENDER SEARCH

The Florida Department of Law Enforcement (FDLE) provides a free, online search option that allows users to search for sexual offenders and predators within a geographic area. Visit floridaoffenderalert.com and click on the <Offender Search> button located in the upper left portion of the page.

OFFENDER ALERT SYSTEM

An offender alert system provided by FDLE complements the above search capabilities and can be used to automatically notify citizens via email alerts when registered sexual offenders or predators move into a designated area. Signing up for notifications is a proactive measure to help residents stay aware of their surroundings and make informed decisions.

The process for signing up for the Florida Offender Alert System is simple and free.

1. **Visit floridaoffenderalert.com**
2. **Create an account.** Click the "New User" button on the login screen.
3. **Enter and submit requested information.**
4. **Activate your account.**
5. **Add monitored locations or offenders.** After logging in, you can add more addresses to monitor or search for specific offenders to track.

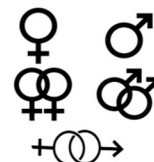

REMINDER OF SIDEWALK REPAIR PARTNERSHIP PROGRAM



Roughly 10 Dana Shores homeowners applied for the Hillsborough County Sidewalk Repair Partnership Program over the past 2 years, resulting in repair of the sidewalk adjacent to their home at no cost to the homeowner. Thank you! Everyone who uses our neighborhood sidewalks should appreciate these improvements.

We estimate an additional 40 – 45 Dana Shores homeowners could qualify for this program. This is an opportunity for those homeowners to return some of our tax dollars to the community, improve safety, and reduce your potential liability.

The sidewalk partnership program reopened on October 1 with funding available for up to 100 approved homeowners throughout the County. Approval will be provided for those who qualify on a first-come, first-served basis. Neither the civic association nor another entity can qualify for this program – it's only available to the homeowner who has a sidewalk in need of repair in front of (or in some cases to the side of) their home.

SAMPLE ELIGIBILITY CRITERIA (ABBREVIATED)

- Raised/splintered/cracked sidewalks of more than 1/4" offset between panels
- Sunken sidewalks actively pooling more than 1/2" of water after rainfall/ irrigation
- New sidewalk installation to fill gaps of up to 20' between existing sidewalks

Some have asked about vendors to perform the work. It is our understanding that Mark Cahill General Contracting has performed the majority (if not all) of the work for the approved homeowners in Dana Shores.
